### The grounds of tender

Article 1150 of the Civil code of Ukraine, the Decision of the Fifth session of the VII Convocation of the Kyiv City Council "On some issues on handling household waste in the city of Kyiv" No. 697/3704 dated December 14, 2017, Provisional order of the Kyiv City Council (Kyiv City State Administration) "On the introduction in effect of the decision of the Tender Committee on selection of Service Provider for removal of household waste on the territory of Kyiv" No. 1589 dated December 8, 2017, The Law of Ukraine "On Waste" and "On housing and communal services", Provisional order of the Cabinet of Ministers of Ukraine "On approval of the national waste management strategy in Ukraine until 2030" No. 820-R dated November 8, 2017.

The tenderers may be business entities of all ownership forms.

Home and foreign tenderers take part in tender on equal terms.

Tenderer provides a Tender Security in the form of a bank guarantee in the amount of 31500 thousand UAH. (thirty-one million five hundred thousand UAH.) with a validity of 120 days from the date of announcement of the first stage of the tender.

The tender documents are provided within three working days from the date of receipt of written statement for participation in tender from the tenderer.

The tender offer is provided simultaneously in two sealed envelopes according to each stage separately with markings on envelopes that contain the name, the address of the Tender Initiator and the tenderer, the subject of tender, no. of stage, contact phone number.

#### 4. Tender security

4.1. Tender security is securing performance of obligations of the tenderer to the Tender Initiator, arising from the submission of tender offer in the amount of 31500 thousand UAH. (thirty-one million five hundred thousand UAH), with validity period of 120 calendar days from the date of announcement of the first stage of the tender.

The tender security shall be provided in the form of a bank guarantee.

- 4.2. Tender security in the form of a Bank guarantee is not refundable in case of:
- -revocation of a tender offer after the expiry of the submission period for tender offer specified in the announcement:
- -refusal of the tenderer who became the successful tenderer based on the results of the tender to conclude the contract.
- 4.3. Tender security in the form of bank guarantee shall be returned within five banking days from the date of the following grounds, namely:
  - -conclusion of the contract with successful tenderer;
  - -revocation of the tender offer before the end of the deadline specified for submission;
  - -declaration of the tender's failure;
  - -absence of the contract based on the results of the tender with any tenderer.
  - -the rejection of the tenderer's tender offer in the first stage (returning after the submission of the statement of the tenderer prepared in optional form to the Chairman of the Tender Committee).

#### 5. General part

- 5.1. Preparation and holding of the tender are carried out by the municipal enterprise of Executive body of Kyiv City Council (Kyiv City State Administration) "Kyivkomunservis" (hereinafter" ME "Kyivkomunservis", the Company). «КИІВКОМУНСЕРВІС»
  - 5.2. Tenderers can be domestic and foreign business entities, regardless of the form of ownership.
  - 5.3. The number of tenderers is not limited.

- 5.4. The tender documents are provided by Tender Initiator within three working days from the date of receipt of written tender application from the tenderer.
  - 5.5. The tender is held in two stages.
- 5.6. The deadline for submission of tender offer is within 30 days from the date of publication of the announcement of the tender in the media.
  - 5.7. Tender Committee
- 5.7.1. The decisions the adoption of which is envisaged in the course of the tender are accepted by the Tender Committee established by the Tender Initiator.
- 5.7.2. The decisions of the tender committee are deemed to be in effect if there is more than half of the quantitative composition of the Tender Committee at the session.
- 5.7.3. The decisions of the tender committee are adopted by the Tender Committee at the meeting by open voting by a simple majority of Tender Committee and are to be officially recorded in the form of minutes. In case of a tied vote the deciding vote is cast by the Chairman of the Tender Committee.
- 5.7.4. The decisions of the Tender Committee are recorded in form of minutes which are signed by the Chairman and Secretary of the Tender Committee.
- 5.7.5. The tenderer has a right to make a written request to the Tender Initiator for clarification regarding the contents of the tender documents no later than ten calendar days before the deadline for submission of tender offers.

The tender initiator within three working days of receipt of the request for provision of clarification before the deadline for submission of tender offers shall provide a written clarification.

5.7.6. In case of receiving two or more requests for provision of clarification regarding the tender documents, the Tender Initiator shall conduct the meeting of tenderers with the aim of provision of appropriate clarification. The Tender Initiator shall report within three working days the place, time and

The tender initiator keeps the minute of meeting mentioned above, which is registered and sent or given to all the participants on the date of this meeting.

- 5.7.7. The Tender Initiator has the right to amend the tender documents no later than ten working days before the deadline for submission of tender offers; and within three working days the tender initiator in writing form notifies all tenderers to whom the tender documents were sent.
- 5.7.8. In case of late modifications to the tender documents or late provision of clarifications regarding its contents the tender initiator extends the deadline for submission of tender offers for no less than ten working days from the date of any modifications; and all the tenderers shall be notified of this extension.
- 5.7.9. The tender initiator has the right to make the decision regarding extension of the deadline for submission before the end of the deadline for submission of tender offers. The Tender Initiator shall notify all the tenderers, who submit the documents for tender, of his decision and also of the change of the place, date and time of tender offers opening.
  - 5.8. Tender offers shall be rejected if:
  - 5.8.1. The tenderer does not meet qualification requirements provided in the tender documents
  - 5.8.2. The tender offer does not meet the requirements of the tender documents;
- 5.8.3. The errors made by tenderer, which affect decision-making, were detected at any stage of the tender or if the fact of submission of false information was found;
- 5.8.4. The tenderer is in a state of cessation or is declared bankrupt or if the bankruptcy proceeding was violated.
  - 5.8.5. The tenderer fails to provide tender security

5.8.6.If the balance of household waste declared by the tenderer in the tender offer, given the capacity of the facility(s) and the proposed by tenderer conversion technology is over 60 %.

- 5.9. The tender declared invalid, if:
- 5.9.1. There is no tender offer;

5.9.2. All the tender offers were rejected on the grounds stipulated in clause 5.8.

5.10. The employer has the right to declare tender invalid:

5.10.1 if participation in the second stage of the tender was allowed only for one tender offer, which, according to the criteria and procedures (methods) of evaluation, scored less than 50 points.

5.10.2 if a further holding of the tender is impossible due to force majeure;

5.11. in case of acceptance of decision by the Tender Committee on the recognition of the tender failure all the tenderers who submitted tender offers within three working days from the date of acceptance of the relevant decision shall be notified.

## 6. Formulation and submission of tender offer

6.1. The tender offer is prepared by the tenderer on the basis of the tender documents on each separate stage specified in this documents.

All the documents that are part of the tender offer and prepared directly by the tenderer shall be drawn up in Ukrainian language.

The Non-resident tenderer shall provide documents (substitute of documents) specified in this tender documents, given the specificities of the legislation of the country in which the Tenderer was registered. In case of provision of the substitute of document or in the absence of such a document and its substitute, the non-resident tenderer must add to the tender offer an explanatory note including the legal grounds of failure to provide relevant documents.

To confirm the validity of originals of official documents for the purpose of using them on the territory of Ukraine they should be duly legalized or certified with a special stamp "Apostille" if the state in which the tenderer is registered signed the relevant Convention, unless there are agreements between two or more states that cancel or simplify this procedure or exempt the document itself from legalization.

The documents are legalized by the tenderers who are the foreign business entities in the following

a) through the simplified procedure of affixing Apostille in accordance with Articles 3 and 4 of the Hague Convention dated October 5, 1961

b) through the procedure of consular legalization in accordance with the Vienna Convention "On Consular Relations" dated 1963

- c) through notarization (if the document does not require legalization in accordance with the international agreement (Convention etc.) between Ukraine and state of tenderer), and in such case shall be provided an explanation letter written in optional form signed by the authorized person of the tenderer and affixed with the seal with reference to the corresponding international agreement (the Convention etc.) between Ukraine and state of tenderer according to which the document does not require
- 6.2. The tender offer consist of documents and information according to the requirements specified in Annex 1 (qualification part) and Annex 2 (the substantive part), of the tender documents.

6.3. The tender offer should be bound and numbered and should have register of submitted

documents with indication of page numbers separately for each part of the relevant stage.

- 6.4. At the first stage all tenderers are proposed to submit qualification part of tender offer, which provides information on compliance of tenderer with the qualification criteria and requirements specified by the employer in the tender documents (Annex 1).
- 6.5. At the second stage all tenderers are proposed to submit the substantive part of tender offer, which provides information on the ability of tenderer to perform services in regard to processing (treatment) of household waste generated on the territory of Kyiv in accordance with the requirements specified by the employer in the tender documents (Annex 2).
- 6.6. The tender offer of the non-resident tenderer should contain the relevant documents stipulated by the legislation of the state in which the tenderer is registered.
- 6.7. All pages of the proposal should contain the stamp impressions\* of the tenderer and the signature of the authorized person (persons). The tenderer is fully responsible for printing errors in the documents sent to the Tender Committee and signed appropriately. Iдентифікаційний код 33745859
- 6.8. The tender offer is submitted simultaneously and personally for two stages or sent by mail to the Tender Committee in separate sealed (according to the stages) envelopes which contain both the full

name and address of the tender initiator and the tenderer, including: name, address, contact telephone numbers of the tenderer, the subject of the tender, no. of stage according to the announcement of the tender documents. The integrity of the envelopes should bear seal\* of the tenderer and signature of the

- 6.9. The tender offer shall be submitted to the Secretary of the Tender Committee at the address: 23, Kudryavska street, Kyiv, 04053, room 101 or sent by mail not later than the time and date stated in the announcement.
- 6.10. The tender offers are registered by the Tender Committee in the register of tender offers maintained by the Secretary of the Tender Committee. If sent by mail, at the request of the tenderer the Tender Committee represented by Chairman of the Tender Committee confirms the receipt of tender offer
- 6.11. The tenderer has the right to withdraw its tender offer or make changes to it before the end of the deadline for submission of tender offers.
  - \* If the seal was used by tenderer

### 7. Tendering procedure

- 7.1. To participate in the tendering procedure the tenderers or their authorized persons provide a document that confirms the authority for such participation and present a document, which certifies the
- 7.2. Opening of envelopes with tender offers is carried out on the day, time and place specified in the announcement, in the presence of tenderers or their authorized persons, who are present during the
- 7.3. Opening of envelopes with the tender offer may be conducted in the absence of tenderer or his authorized person.
- 7.4 At a time of the tendering procedure specified in the announcement the Secretary of the Tender Committee examines the credentials of tenderers' representatives for participation in the tendering procedure. The presented documents that confirm the credentials of tenderers' representatives are attached to the minutes of the meeting of the Tender Committee.
  - 7.5. At the beginning the Chairman of the Tender Committee announces the start of the tender.
- 7.6. The number of tenderers that submitted the tender offers, their name and location are announced.
  - 7.7. The First Stage (Qualification stage):
- 7.7.1. During the opening of envelopes of the First stage of tender, Tender Committee verifies the existence and the satisfactory form of the qualification part of tender offer, the submission of which is stipulated in the tender documents.
- 7.7.2. After the opening of the qualification part of the tender offer, the tender offers are examined for compliance with the requirements established in the tender documents of the first stage within a period not exceeding one month.
  - 7.7.3. All tenderers whose tender offer wasn't rejected are allowed to the second stage.
- 7.7.4. The results of the consideration of tender offer for the first stage of the tender are announced by Tender Committee at the open session, to which all the tenderers are invited no later than seven calendar days prior to the session.
- 7.7.5. The tenderers have the right to provide explanations and comments regarding to the decision of the Tender Committee on the results of the first stage.
- 7.7.6. The decisions on the results of the first stage and the start of the second stage are made at the session of the Tender Committee.
- 7.7.7. The Tender Committee notifies the tenderer of the results of consideration of tender offer's qualification part and of decisions regarding the admission of tenderers to the second stage or rejection of tender offers.

- 7.8. The Second stage (Substantive part):
- 7.8.1. The Tender Committee during a session examines the substantive part of the tender offers, the submission of which is stipulated in the tender documents.
- 7.8.2. The consideration and assessment of the substantive part of the tender offers which are approved for the second stage is carried out in accordance with the criteria and procedures (methods) of evaluation defined in Annex 3 of the tender documents within 60 days from the date of announcement of the second stage of the tender at the regular session of the Tender Committee.
- 7.8.3. The Tender Committee during the consideration of the tender offers has the right to request the clarification of their content from tenderers.
- 7.8.4. The Tender Committee has the right to conduct the negotiations with each tenderer separately, and additionally the joint meetings may be conducted with all the tenderers. All aspects of tender offers for the purpose of identifying means and solutions regarding the performance of the services that will be provided may be discussed during negotiations. The Employer during the negotiations shall not apply a discriminative approach to the different tenderers and disclose proposed solutions or other confidential information collected from the tenderer who takes part in the negotiations to the other tenderers without its consent.
- 7.8.5. The Tender Initiator or the Tender Committee has the right to seek confirmation of the information provided by the tenderer to the government bodies, enterprises, institutions and organizations.

## 8. Identification of the successful tenderer and conclusion of the agreement

- 8.1. The successful tenderer is a tenderer who meets the qualification requirements, can provide adequate quality of service provision and whose tender offer is recognized the best according to the evaluation results.
- 8.2. The decision on the successful tenderer shall be made within 60 days from the date of announcement of the second stage of tender on the day of evaluation of tender offers.
- 8.3. The successful tenderer is announced at an open session of the Tender Committee to which all of its tenderers or persons authorized by them are invited.
- 8.4. The extract from the minutes of the meeting of the Tender Commission on the results of the tendering is signed by the Chairman and Secretary of the Tender Committee and shall be sent within three working days to all tenderers.
- 8.5. The contract on the processing (treatment) and the disposal of waste services on the conditions mentioned in Annex 4 shall be concluded with the successful tenderer within 20 calendar days after the adoption of the decision. In order to ensure the right to appeal the decision of the Tender Committee, the Tender Initiator concludes the specified agreement no earlier than 10 days from the date of the announcement of the Tender Committee's decision on the selection of the successful tenderer.
- 8.6. In case of refusal of the successful tenderer from signing of the contract or if the conclusion of the contract was failed due to the fault of the tenderer within the deadline the Tender Committee is entitled to select the successful tenderer among the remaining tenderers in accordance with the rating.
- 8.7. The Tenderer shall bear the entirety of the expense associated with the preparation and submission of its tender offer.
